Who We Are

The Wagin Community Resource Centre Inc is a trusted business that has been in operation since 2000 when it first opened as the Wagin Telecentre. The Wagin CRC provides a range of services to meet the community's needs, ranging from printing, photocopying and secretarial services to photo printing, workshops, training development programs and the community newsletter.

The Wagin CRC is a not-for-profit organisation that works to improve access to government services and economic, business, and social development opportunities for the people within the Shire of Wagin and surrounding districts. We are funded by a mixture of state government contracts, userpays services, membership fees, and grants for projects as well as small donations during the year.

This enables us to offer a five day a week service to the residents and visitors to Wagin. We offer a wide range of services including free online access to Federal, State and Local government information via our Government Access Point, regular business and social development activities and services and visitors' information. We also provide a range of professional printing and desktop publishing services.

We are members of Linkwest (peak body for CRCs) and we are incorporated under the Associations Incorporation Act 2018.

The Wagin CRC aims to remain a highly professional and reliable resource to the businesses and community members of the Shire of Wagin and surrounding areas as well as being an educational information centre for residents and tourists alike. We aim to ensure we provide every person walking through the door with the latest "up to date" information on community, government, information technology and tourism. To do this, we will continue to concentrate on training for both staff and committee members to provide direction and the skills to implement our Business Plan.

Here at the Wagin CRC one of our goals is to be able to provide our community with opportunities to learn about technology and how it can benefit them. We host monthly Senior IT sessions and are available for 1 on 1 appointments. Partnering with Be Connected, we want to be able to empower our community to thrive in a digital world.

The Wagin CRC also has a strong focus on remaining very active within the community and is always looking for new ways to interact with the community, identifying needs and helping organise, facilitate, or sponsor local and regional events and initiatives to meet those needs. We work proactively with our local community to continue to grow and stay connected with community needs.



Chairperson's Report

When I came on board as the new chairperson for the Management Committee 12 months ago, I was extremely green and in all honesty, quite nervous. At that time, I knew that our CRC provided services and opportunities to our community and that it was an integral business for our town. That is where my knowledge stopped. However, over the last 12 months I have made myself known to DPIRD and Linkwest (which are our primary sources of funding and support), poured over constitutions, policies and procedures and familiarised myself with the governance role our Management Committee plays in our CRC.

I could go on to tell you about the State Government Technology Grant of \$10,940 we were successful in receiving recently that has gone towards purchasing a BenQ Interactive Flat Panel. This is already being utilised by community members who are accessing our facilities. I could also go on to tell you that we are looking forward to being part of one of 13 buildings in Tudhoe Street that is going to get a much-needed facelift, thanks to an initiative by the Shire of Wagin and the Wagin Chamber of Commerce. A Federation style painting project will revive the buildings and renew interest and attraction to the town and its businesses.

However, what I would really like to tell you about is the number 1 thing that I have realised in the last 12 months to be the most important part of our CRC, and that is the staff. I have had the pleasure of working closely with our Manager Jasmine Watson and her experience and knowledge is to be commended. Her competence to carry out all operational aspects and provide support and encouragement to her staff to do the same is vital to the success of our CRC. During my earlier months when I was still finding my feet, I felt great comfort in knowing that they had the operational side of our CRC well in hand, which gave me the opportunity to focus on the governance side. Luke Jenkin successfully finished his traineeship and has received his Certificate 3 in Business and is now off working and travelling Australia. His happy smile and helpful nature will be missed by all. I had the pleasure of being involved in interviews for our current trainee Claire Ballantyne and all reports so far suggest she is a great addition to our team, well received by the community and enjoying learning new skills in her role. Zach Rayne continues to be a solid CSO, providing excellent customer service to our community, great mentorship to our trainees and continues to push the Wool Press to new levels.

Complimentary to our incredible staff is our wonderful Management Committee – the other group of people who have been very supportive in my journey as Chairperson. Without a diverse group of invested volunteers willing to give up their time to meet and provide governance for such an important service, the CRC would be at a loss. I'd like to take this opportunity to thank Jessica Hamersley and Vicki Daley, who resigned this year from their roles as Secretary and Vice Chair respectively, for their valuable time and contributions to the Management Committee over the years.

We always welcome new members so if you don't know much about the CRC but would like to be involved, come along and we can learn together.

Going forward, I am excited to learn more about all aspects of our organisation and to work alongside the committee, staff and community to ensure the successful future of our Community Resource Centre.

Managers' Report

The 2022-2023 financial year has been a successful one for the Wagin CRC. We've had successful grant applications, our Trainee completed his course, fun and exciting activities and events, the introduction of Foodbank to our Centre and other things that I will go into.

Thanks to funding from the Be Connected Program and the Good Things Foundation, we were successful in our 3 grant applications. These grants provided funding to run an event for Get Online Week, support for our Be Connected IT sessions and the provision of multiple devices such as tablets and laptops which are available to our community to hire.

We were also successful in our Traineeship grant application. This grant provides us with the funding to be able to support another employee at the Wagin CRC. This provides more employment opportunities within our Community as well as providing the Trainee with access to further education and a qualification upon completion. We welcome Claire Ballantyne to our team thanks to this generous grant from the Department of Primary Industries and Regional Development.

On the topic of trainees, we congratulate Luke Jenkin who completed his traineeship with us in April 2023 as well. Luke started with us in February 2022 and worked hard to complete his Certificate 3 in Business. Luke was a valued member of our team and provided our Community with quality service and support. We wish him well in his future endeavors.

2022 also saw the introduction of Foodbank to the Wagin CRC. Foodbank through sponsorship from ARC Infrastructure are providing our Community with Food Hampers which are available to anyone who may need some food relief. With rising costs hitting households hard, these hampers can help decrease that burden by providing enough staple food items for a family of 4 to last 2 days. We would also like to mention the Wagin Care & Share and the Wagin Co-Op who are both supporters of this program by way of funding and provision of goods. To date, we have provided our community with 299 food hampers.

At the Wagin CRC, we are trying to keep our Community loaded up with activities targeting both our social and business outcomes. One of our regular offerings is our Paint & Sip evenings. Our Paint & Sip evenings are a unique combination of art and socializing. The event is open to people of all skill levels, from beginners to experienced artists. Participants are provided with all the necessary materials, including canvas, paints, and brushes. As the participants paint, they have the opportunity to relax and enjoy a glass of wine or a non-alcoholic beverage of their choice alongside some nibbles. This adds a fun and social element to the evening, allowing people to connect with each other and create new friendships within the community.

Our School Holiday Programs are also being widely utilised by our junior community members and it's been great seeing new faces at our activities. We have added Paint & Cookie sessions to this program as well as sports, crafts, Christmas activities and collaborating with Wagin Woodanilling Landcare Zone to deliver a bird house project.

A highlight of this year for me has been attending my first Linkwest conference in April 2023. This conference provided great opportunities to connect with fellow CRC professionals and gain insights into their experiences and best practices. It was refreshing to hear different perspectives and learn about innovative ideas that could be implemented in our organisation.

Overall, I think the 22-23 year has been a successful one thanks to the sound leadership and direction from my committee and the hard work of our employees. We look forward to the continued success of the CRC and thank our community for its support.



Rob Carter, Nool Classing Lecturer from Swath Regional TARE Narrogin, gave a shearing demonstration to students from Wagin District High School as part of the 'Careers Tatler Program'. Not all career pathways are necessarily academic and, as was discussed in a previous Woolarama article, the Australian Wool inclustry needs an higheritorian of youthild enthusians if we are going to continue to produce wool at an even increasing rate due to a worldwide demand.



Rob shared with the students some interesting Wool facts:

Just add sheep, worker, sunshiel if there is grass to eat, sheep confinue to praduce wool. Wools made 405% arganic cathon, captured from the atmosphere prior to the fresh wool being short Wools in 208 biodegradable and even when its Recycle is done and disposed of, wool naturally decomposes, releasing valuable nutrients back into the earth.

Shearing lan't the only option as the wool handling (which is a major competition at Woolarama each year), wool classing and pressing are all components of a shearing team that services wool practures. Whill the work is physically demanding the rewards are many and the financial compensation can be very appealing. There are not too many industries that can offer a new student fresh on the board the sort of income that can be derived from being a part of a shearing team.


TREASURER'S REPORT

The 2022-2023 Financial Year saw the Wagin CRC finish the year off with a \$44,666.13 profit. As a not-for-profit organisation, this was a fantastic outcome and one that exceeded our expectations. This outcome was achieved through the hard work of our staff and the indepth, hands-on management from our Committee.

With the cost of equipment, general office supplies, utilities & other services increasing throughout the financial year, the Wagin CRC was able to absorb those increases, whilst ensuring we kept our facilities & equipment operational and affordable to all those who utilise the CRC.

We received multiple grants that allowed us to purchase new equipment, including an interactive BenQ Projector Screen & accessories that replaced the existing setup in our conference room and laptops & accessories for a device loan program that forms part of our Be Connected sessions.

Financial Report Audit for the Year Ended 30 June 2023

We have completed the audit of your Association's accounts for the year ended 30 June 2023. We enclose one copy of the audited financial report for your attention.

We direct your attention to the fact that the responsibility for the preparation of the financial statements and adequate disclosure is that of the Committee. This includes the maintenance of adequate accounting records and internal controls, the selection and application of accounting policies and the safeguarding of monies of the Association.

The purpose of our audit of the financial report is to express an opinion on that report and this report on management issues includes only matters that come to our attention during the conduct of our work and therefore should not be regarded as a comprehensive statement of management issues that may exist.

Our audit procedures highlighted the following issues for your consideration and implementation where possible.

Qualified Audit Report

Cash Income

As is common for organisations of this type, it is not practicable for your Association to maintain an effective system of internal control over cash receipts until their initial entry in the accounting records. Accordingly our audit in relation to cash income was limited to the amounts recorded.

Audited Financial Report

We have determined the financial report is not materially misstated after the adjustment of the following:

- Recognition of prepaid insurance
- Movement of annual leave balance

Other than the above, we noted no other significant matters that should be raised or brought to the attention of the Management Committee.

Note 1 Summary of Significant Accounting Policies

Financial Reporting Framework

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2015 (WA). The committee has determined that the association is not a reporting entity.

Statement of Compliance

The financial report has been prepared in accordance with Associations Incorporation Act 2015 (WA), the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: '*Presentation of Financial Statements*', AASB 107: '*Cash Flow Statements*', AASB 108: '*Accounting Policies, Changes in Accounting Estimates and Errors*' and AASB 1054: '*Australian Additional Disclosures*'

Basis of preparation

The financial statements have been prepared on an accrual basis and are based on historical costs. They do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

(a) Income Tax

The Association is a non-profit organisation and thus exempted from income tax liability by virtue of 23(3) of the Income Tax Assessment Act.

(b) Property, Plant and Equipment (PPE)

Land and Buildings are carried at cost

(c) Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

(d) Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(f) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(g) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

Interest revenue is recognised upon receipt

Grant income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

(h) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

(i) Accounts payable and other payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid.
